

Morning Class Guidelines

Very Advanced: ability to perform all steps and formations to a very high standard of accuracy with minimal instruction, to show excellent phrasing, covering and handing, and the fitness to sustain this very high level of performance throughout the course. Willingness to accept individual criticism.

Advanced: ability to perform all steps and formations to a high standard of accuracy with minimal instruction, and to show good phrasing, covering and handing. Willingness to perform to limit of personal fitness and to accept individual criticism.

Advanced Social: possession of many years of dancing experience and a knowledge of all aspects of dancing. For dancers who would prefer less emphasis on footwork.

Intermediate: ability to perform most steps and some formations. For dancers who wish to improve steps and technique and who possess, preferably, at least two years of recent dancing experience.

Note that class types may be altered depending on the number and mix of dancers who register.

The Winter School committee will endeavour to allocate dancers to a class of their choice but reserves the right to allocate individuals to an alternative class.

Booking Conditions

Personal injury and loss or damage to property: Persons attending this school do so at their own risk.
